You are responsible for the first <b>GBP 50</b> of any claim.  |
| <b>Exhibitor Liability</b> | <b>GBP 2,000,000 any one occurrence</b> | Legal liability to pay compensation, legal costs and expenses as a result of accidental death or injury to a third party and/ or damage to their property at the Venue. You are responsible for the first <b>GBP 250</b> of any claim for third party property damage.  |
